Total portfolio deposited with DCV decrease by 0,2%

The total balance of the investment portfolio on deposit with DCV at the close of January 2014 totals UF 6,492 million, equivalent to USD 278 billion. This represents a 0.2% increase relative to the previous month's balance and a 3.2% increase in relation to January 2013. This total amount in custody is comprised 99.7% by local custody (98% by securities position accounts, and 2% by BRAA accounts) and 0.3% by international custody.

The total portfolio by type of instrument at January 2014 is comprised as follows:



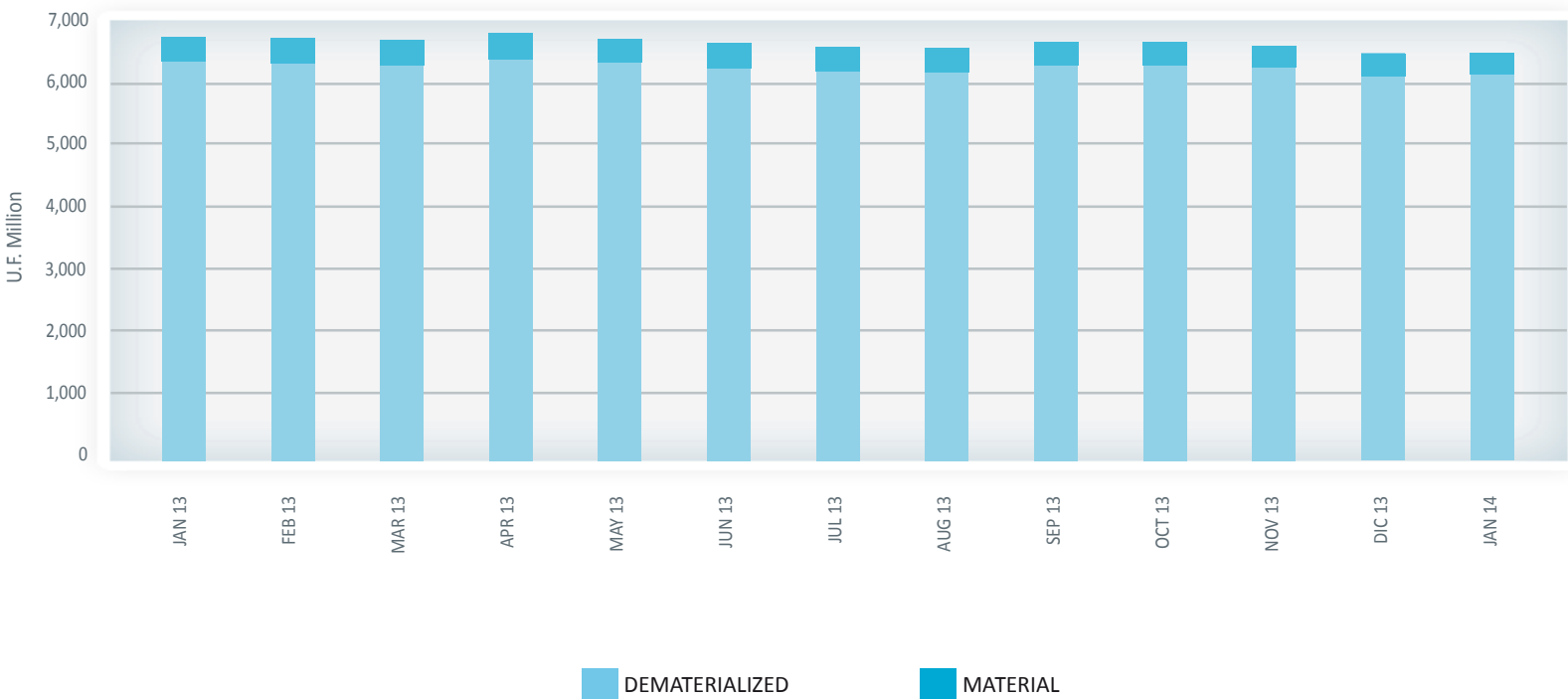

The total investment portfolio deposited in the CSD consists in 94.9% of instruments issued in dematerialized form and by 5.1% in fitness.

Composition of the local custody

The investment portfolio deposited in the corresponding DCV to local instruments, UF reached 6,470 million (U.S. \$ 277.1 billion) at the end of the month of January 2014, representing a decrease of 0.2% from the previous month and 3.3% growth compared to January 2014.

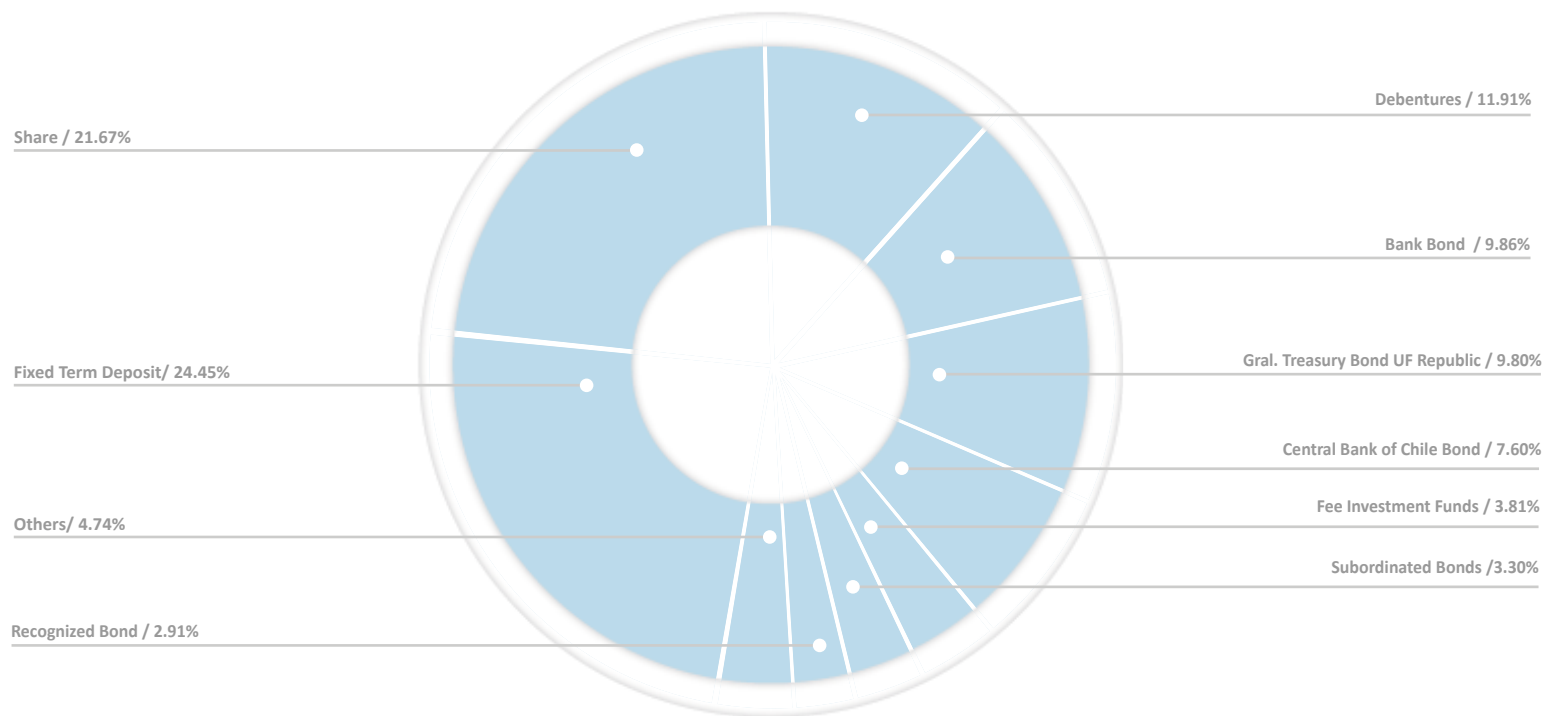
The total of the local custody is comprised of the balance in position accounts equivalent to UF 6,338.5 million, in addition to UF 131.6 million in Active Affiliates Recognition Bonds (BRAA) maintained in inventory accounts.

The total national investment portfolio on deposit with DCV is comprised 94.9% of instruments issued in dematerialized form, and 5.1% issued in physical form.

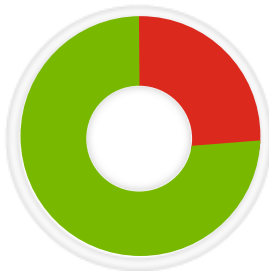


Composition of the international custody

The volume of the international custody amounted to UF 21.7 million (USD 930.5 million) at the close of January 2014, representing a 4.8% increase relative to the previous month, and an 42.5% increase in relation to January 2013.

The total of the international custody is comprised of the international custody balance equivalent to UF 19.1 million, in addition to UF 2.6 million, corresponding to the balance of the securities in custody traded in the foreign securities exchange (BE).

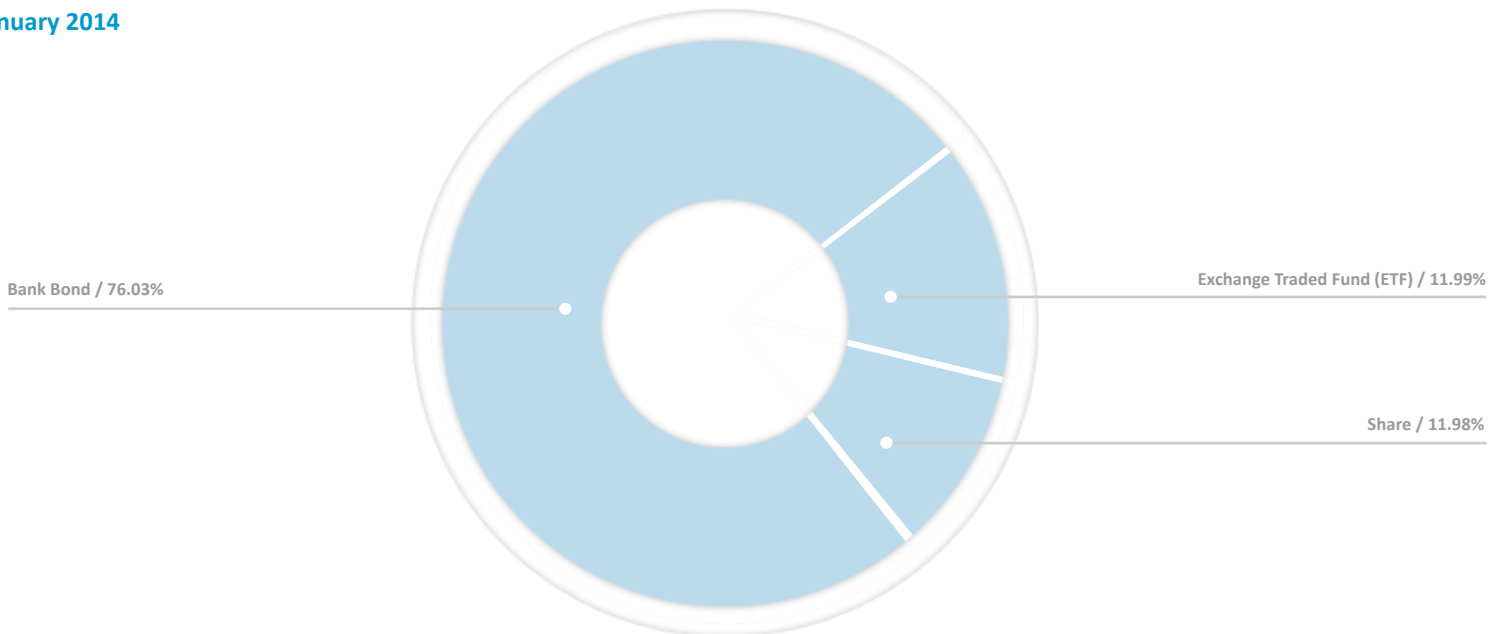

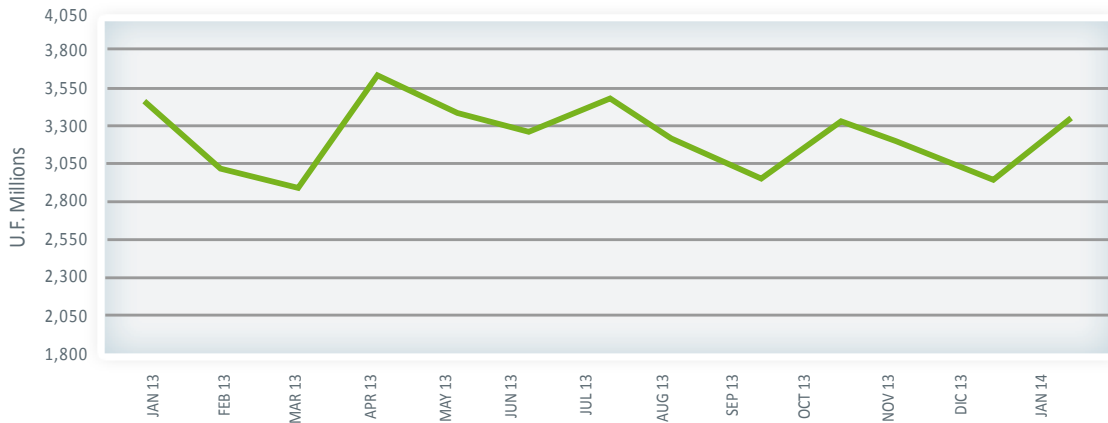


Transactions registered in DCV Transactions UF

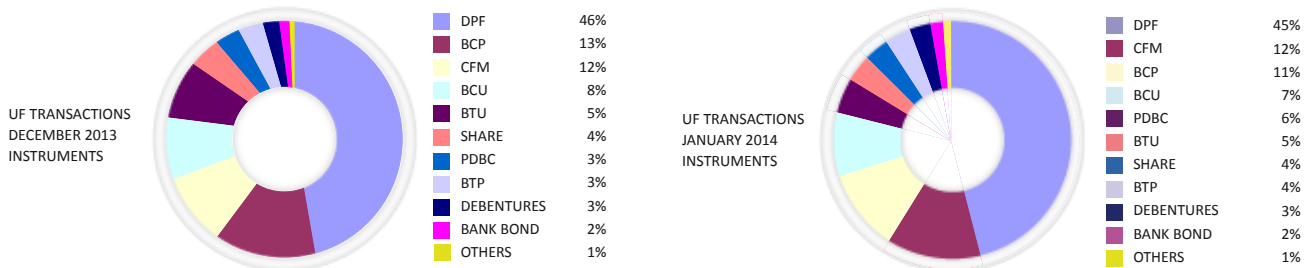
The volume of transactions registered with DCV in January 2014 amounted to UF 3,572 million (USD 153 billion), which represents a 12% increase relative to the volume traded and registered the previous month, and a 3% increase compared to January 2013.

The following graph shows the progression of the amounts registered in DCV systems during the period between January 2013 and January 2014.

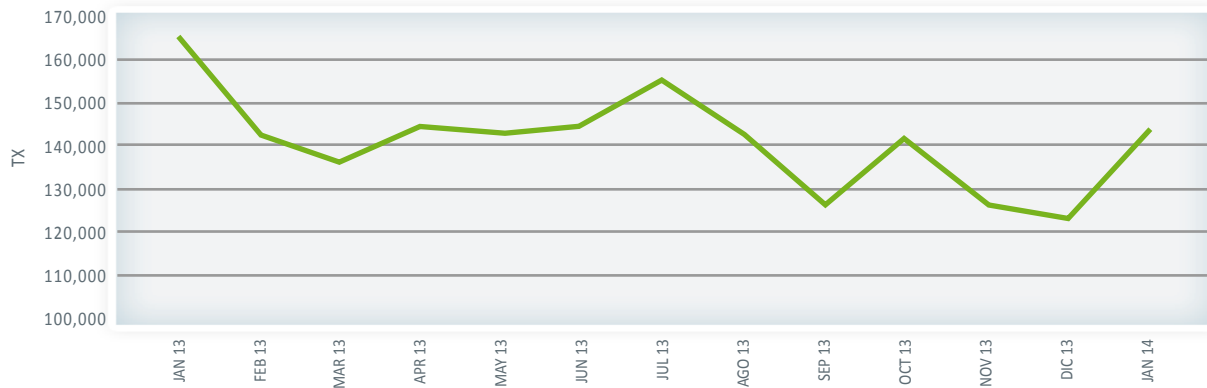


Number of transactions

The number of transactions registered in DCV in January 2014 amounted to 143,191 a balance that represents a 16% decrease relative to the previous month, and a 13.2% decrease compared to the same month 2013.

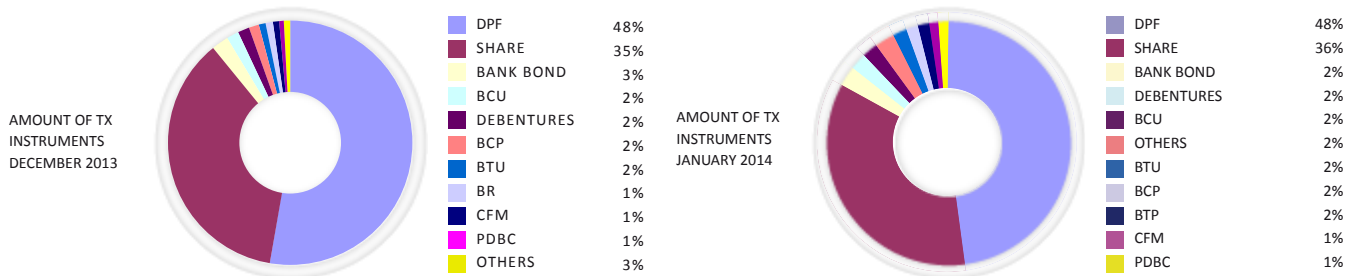
The following chart shows the progression of the number of transactions registered in DCV systems between January 2013 and January 2014:

In January 2014, the percentage of exchange transactions between brokers was 23.5% (23.5% in 2013), while the transactions between investors and brokers and the over the counter market amounted to 76.5% (76.5% in 2013). In addition, the number of transactions involving instruments that originate from private debt and variable income instruments was 91.3% (94.8% in 2012), and that of public debt, 8,7% (5.2% in 2013.).

The greatest number of transactions in the December 2013 and January 2014 periods involved the following instruments:





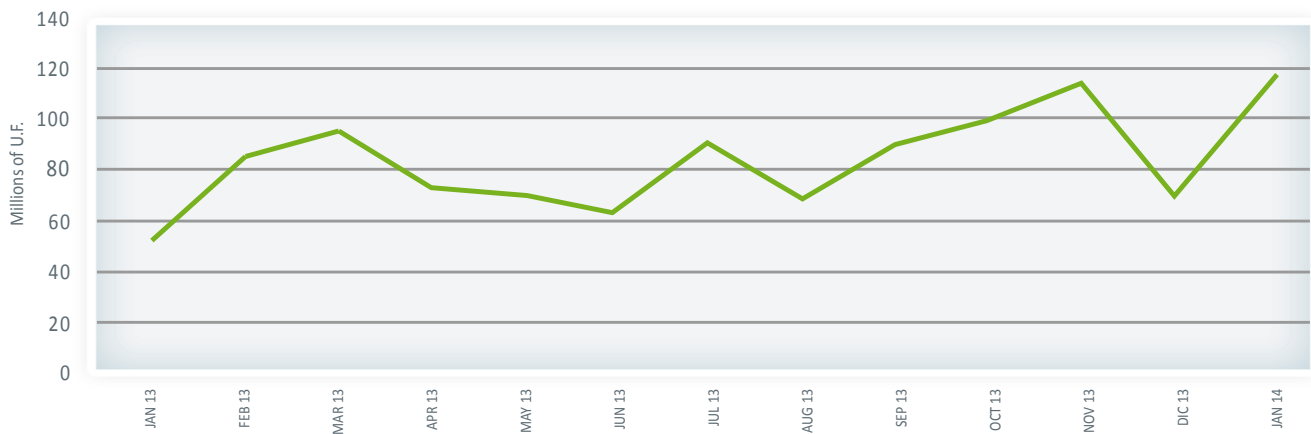
Transactions registered in DCV – Forward Service

Contract subscriptions – Type of CLP – UF Forward operations

The amount of CLP – UF Forward operations registered in DCV at January 2014 amounted to UF 118 million, which represents a 74.3% decrease relative to the amounts registered during the previous month.

Subscription contracts - Exchange Operations in million CLP-UF

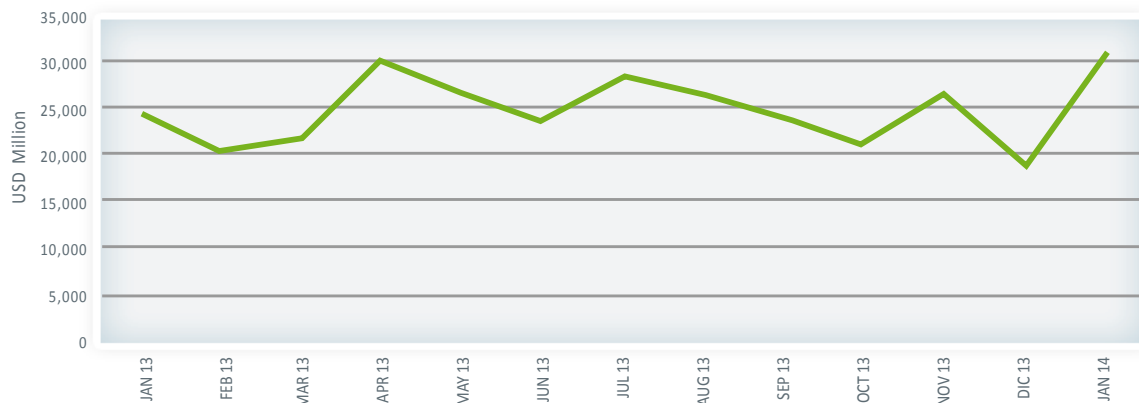


Subscriptions Contract - Forward Exchange operations CLP - USD

The amount of Forward contracts CLP - USD recorded in the DCV in January 2014 reached USD 30.7 billion, representing an increase of 64.8% compared to the amounts recorded in the previous month.
