International meeting of lawyers expert in the securities depository industry



uring Monday the 29th and Tuesday the 30th of August, more than 20 lawyers expert in the securities depository industry gathered in our country on the occasion of the first ACSDA Lawyers Workshop (Americas' Central Securities Depositories Association), event organized by DCV and this association.

Deemed as a success by the attendees representing 12 countries, the event achieved the intended purpose of providing an opportunity for lawyers who are members of ACSDA and other experts to have the possibility to exchange experiences, share knowledge, good market practices and legal work strategies in relation to the securities custody industry worldwide.

Among the topics addressed were: The usefulness of the Hague and Unidroit conventions for central securities depositories and the state of both conventions to date; digital

evidence and the use of the electronic signature; legal challenges in cross-border links; the process of integration in the European Union market; the experience of MILA (Chile - Colombia - Peru Integrated Markets);

tax issues in cross-border links; the impact of the new CPSS and IOSCO Principles related to financial market infrastructures (focused on central securities depositories) and corporate governance in the securities custody, clearing and settlement industry.

Development states: "Today there are not many opportunities to deal with legal issues in depth, considering the nature of our industry (a single depository per country) and ACSDA events (conventions, seminars, ALF) generally address various issues, not focusing on this area (juridical issues) which are essential for the proper development of securities clearing, settlement and custody activities."


