



#### Total portfolio deposited with DCV increase by 1.9%

The total balance of the investment portfolio on deposit with DCV at the close of April 2015 totals UF 6,997 million, equivalent to USD 285.4 billion. This represents a 1.9% increase relative to the previous month's balance and a 6.1% increase in relation to April 2014. This total amount in custody is comprised 99.6% by local custody (98.6% by securities position accounts, and 1.4% by BRAA accounts) and 0.4% by international custody.

The total portfolio by type of instrument at April 2015 is comprised as follows:





The total investment portfolio deposited in the DCV consists in 96% of instruments issued in dematerialized form and by 4% in fitness.

The following table shows the evolution of the portfolio held in custody at the DCV.








#### Composition of the local custody

The investment portfolio deposited in the corresponding DCV local instruments, UF reached 6.968 million (284.3 billion dollars) at the end of April 2015, representing an increase of 2% from the previous month and a increase of 6% compared to April 2014.

The total of the local custody is comprised of the balance in position accounts equivalent to UF 6,872 million, in addition to UF 96 million in Active Affiliates Recognition Bonds (BRAA) maintained in inventory accounts.


The composition of the local custody according to type of instrument is as follows:



The total national investment portfolio on deposit with DCV is comprised 95.9% of instruments issued in dematerialized form, and 4.1% issued in physical form.

#### Composition of the international custody

The volume of the international custody amounted to UF 28.4 million (USD 1,159.2 million) at the close of April 2015, representing a 7.9% decrease relative to the previous month, and an 29.5% increase in relation to April 2015.

The total of the international custody is comprised of the international custody balance equivalent to UF 24.7 million, in addition to UF 3,7 million, corresponding to the balance of the securities in custody traded in the foreign securities exchange (BE).



#### **Composition of the international Holding April 2015**








#### **UF transactions registered DCV**


The volume of transactions registered with DCV in April 2015 amounted to UF 3,525 million (USD 143.8 billion), which represents a 0.6% increase relative to the volume traded and registered the previous month, and a 732% decrease compared to April 2015.

The following graph shows the progression of the amounts registered in DCV systems during the period between April 2014, and April 2015.




The largest volumes of transactions in December 2014 and March 2015 periods were performed on the following instruments.

UF -Transactions April 2014 Instruments








#### Number of transactions recorded in the DCV

The number of transactions registered in DCV in April amounted to 140,055 a balance that represents a 5.8% decrease relative to the previous month, and a 5.7% increase compared to the same month 2014.


The following chart shows the progression of the number of transactions registered in DCV systems between April 2014 and April 2015.

#### Number of transactions recorded in the DCV



#### Contract subscriptions – Type of CLP – UF Forward operations

The amount of CLP – UF Forward operations registered in DCV at April 2015 amounted to UF 145 million, which represents a 26.2% decrease relative to the amounts registered during the previous month.
