

## June 2012 Monthly report on operational volumes

### DCV Portfolio increased 10%

The total balance of the investment portfolio on deposit with DCV as of June 2012 amounts to UF 6,438 million, equivalent to USD 285,8 billion. This represents a 1,4% increase relative to the previous month's balance and a 10% increase in relation to June 2011.

The total investment portfolio on deposit with DCV is comprised 96,3% of instruments issued in dematerialized form, and 3,7% issued in physical form.

### Investment portfolio deposited in DCV

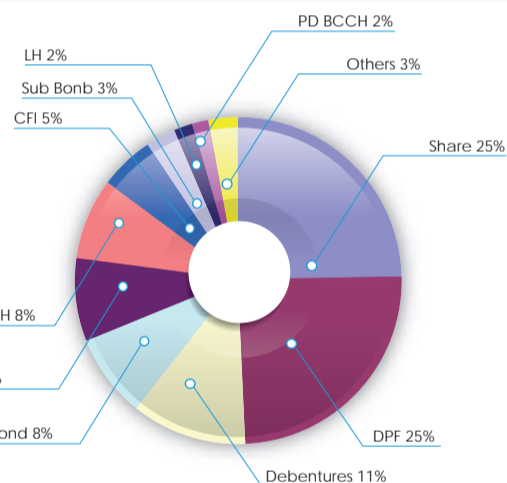
The investment portfolio deposited in dematerialized form with DCV amounts to UF 6,200 million (USD 275.2 billion) at the close of June 2012, representing a 1.5% increase relative to the previous month and an 10,9% increase in relation to June 2011.

Concerning the amount of the investment portfolio deposited with DCV corresponding to physical instruments, this totals UF 239 million (USD 10.6 billion), representing a 1% decrease in relation to the previous month and a 9,5% decrease compared to June 2011.

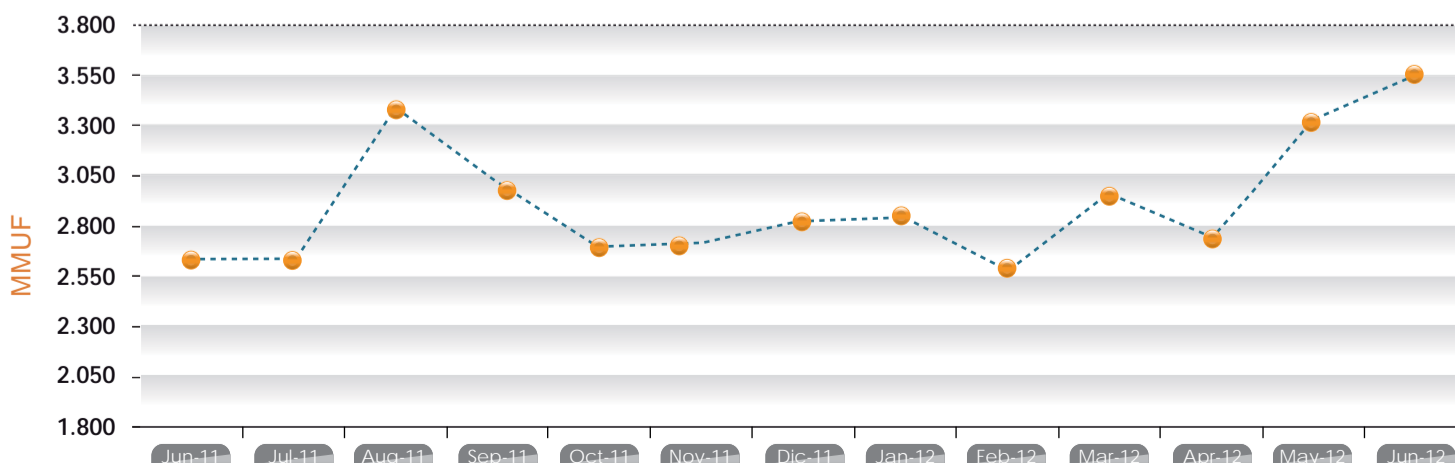
### UF transactions registered in DCV

The amount of transactions registered at DCV in June 2011 reached UF 3,555 million (157.8 thousand million dollars), which represents a 6.9% increase with respect to the amounts transacted and registered in the previous month, and a 35% increase compared to June 2010.

The transactions registered in the January – June 2012 period amount to UF 18,018 million (799,8 thousand million dollars), which represents a 18,3% increase regarding the amounts transacted and registered at same period 2011.

The following graph shows the progress of the amounts registered in DCV systems in the period between June 2011 and June 2012.

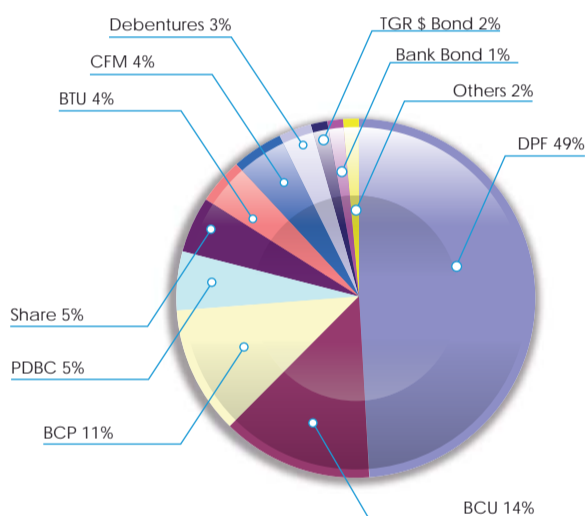
In June 2012, the amount of stock market transactions (between brokers) is 18.4% (20.8% in 2011), whereas the amount of the transactions in the over-the-counter market (which includes transactions between investors and brokers) amounts to 81.6% (79.2% in 2011). Similarly, the amount of the transactions over instruments which originate from private debt and variable income instruments is 64.2% (63% in 2011) and that of public debt, 35.8% (37 in 2011).

In the January – June 2012 period, the amount of stock market transactions (between brokers) is 18.4% (20.9% in 2011), whereas the over-the-counter market (which includes transactions between investors and brokers) amounts to 81.6% (79.1% in 2011).

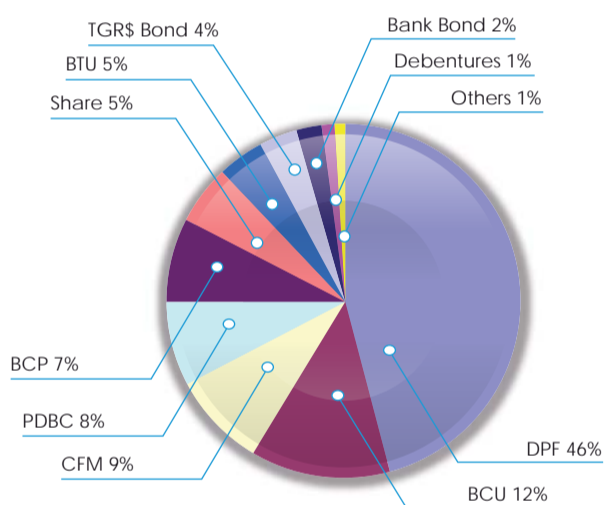
Similarly, the amount of the transactions over instruments which originate from private debt and variable income instruments is 66.5% (60,9% in 2011), and that of public debt, 33.5% (39,1% in 2011).

The highest transaction volumes in the December 2011 and June 2012 periods were performed over the following instruments.

### UF Instrument Transaction June 2012



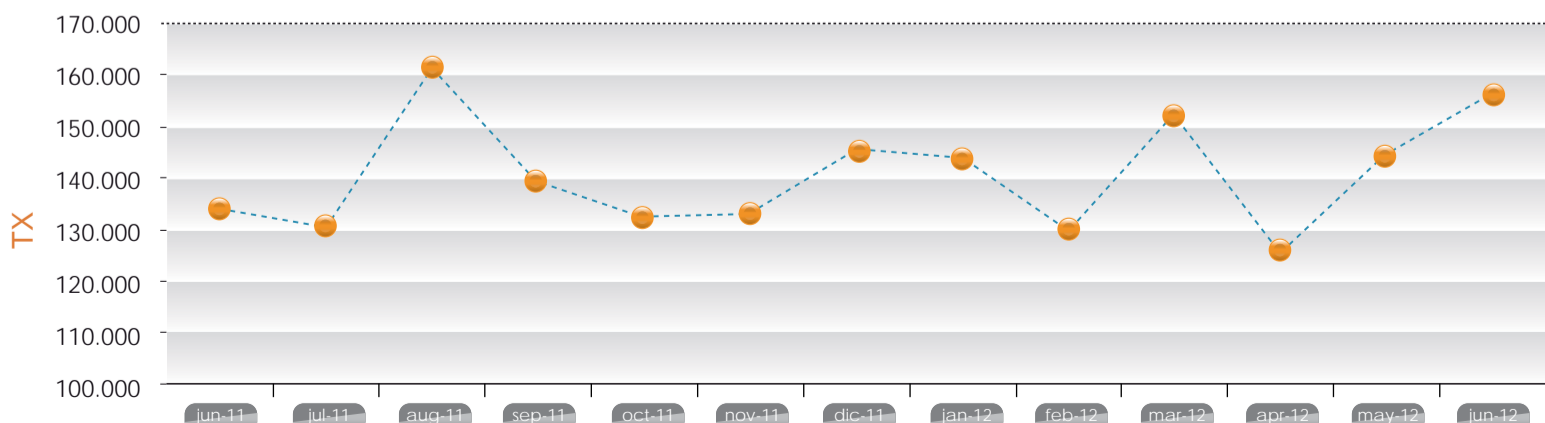
### Number of transactions

The number of transactions registered in DCV in June 2011 amounts to 156,172, balance which represents a 7.8% increase compared to the previous month and a 16.5% decrease compared to same month 2011.

The total accrued in the January – June 2012 period amounts to 853,127 transactions, which represents a 8.7% increase with regard to the number of transactions registered in same period 2011.

### Volume of UF transactions registered in DCV



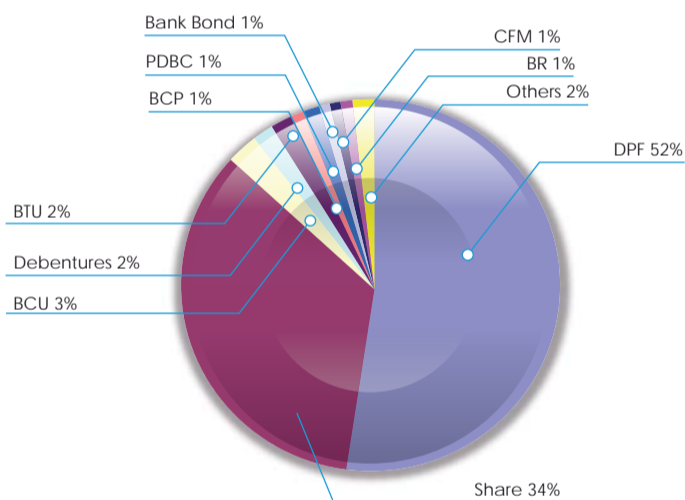

In June 2012, the number of stock market transactions (between brokers) is 21.7% (26.5% in 2011), whereas over-the-counter market transactions (including transactions between investors and brokers) amount to 78.3% (73.5% in 2011). Similarly, the number of transactions over instruments originating from private debt and variable income instruments is 91.2% (92.3% in 2011) and public debt transactions, 8.8% (7.7% in 2011).

In the January – June 2012 period, the number of stock market transactions (between brokers) is 24.2% (27% in 2011), whereas over-the-counter market (including transactions between investors and brokers) amounts to 75.8% (73% in 2011). Similarly, the number of transactions over instruments originating from private debt and variable income instruments is 91.8% (90.6% in 2011) and public debt transactions, 8.2% (9.4% in 2011).

The highest number of transactions in the periods December 2011 and June 2012 were performed over the following instruments.
